AIRSPACE D BALE (LFSB) AS WELL AS RESTRICTED AREA EDR FREIBURG ARE EXCLUDED FROM RMZ/TMZ FREIBURG.

IN RMZ/TMZ FREIBURG ALL VFR FLTS EXC FLTS OF THE GERMAN ARMED FORCES, FLTS BY THE POLICE FORCES AND ON BEHALF OF THE POLICE, FLTS ON RESCUE AND DISASTER CONTROL MISSIONS, ACTUAL AMBULANCE FLTS AS WELL AS MODEL ACFT AND UNMANNED ACFT SYSTEMS UP TO 120M ABOVE GND SHALL USE FREQ 135.600MHZ WITH CALL SIGN -POLICE INFO- AND SHALL SQUAWK CODE A3773 WITHOUT BEING REQ TO DO SO. IF NECESSARY -POLICE INFO- WILL ASSIGN AN ALTERNATIVE SSR CODE.

BEFORE ENTERING RMZ/TMZ, AN INITIAL CALL CONTAINING THE FOLLOWING INFORMATION SHALL BE MADE: -DESIGNATION OF THE STATION BEING CALLED, -CALL SIGN AND TYPE OF ACFT, - POSITION, LEVEL AND FLT INTENTIONS.

CONTINUOUS AIR-GROUND VOICE COMMUNICATION WATCH SHALL BE MAINTAINED ON FREQ 135.600MHZ (POLICE INFO) WHILE FLYING WITHIN RMZ/TMZ. AIRCRAFT SHALL ALSO REPORT WHEN LEAVING RMZ/TMZ. IF THE AERONAUTICAL STATION CALLED DOES NOT ANSWER, THE FLT THROUGH THE RMZ/TMZ MAY STILL BE CONTINUED AS LONG AS AIR-GROUND VOICE COMMUNICATION WATCH IS MAINTAINED. RADIOTELEPHONY REPORTS SHALL STILL BE MADE EVEN IF THE AERONAUTICAL STATION DOES NOT RESPOND. THESE REGULATIONS DO NOT APPLY TO IFR FLTS.
