II. Processing of personal data of the members of our association and of persons applying for admission

Which personal data will be processed, category of processed data

If you are or want to become member of our club, we process (this encompasses amongst others the collection, storage and usage) the following personal data or parts thereof:

- surname, first name, date of birth, gender, date of entry
- particular function in member association (chairman, director, youth leader)
- postal address, telephone number, email address
- bank account (IBAN, BIC), SEPA direct debit authorization available (yes / no)
- for holder of an aviation license: type of license, number of license, date of issue, date of expiry
- for minor: legal representative (surname, first name, postal address)

Additional personal data may be collected when using additional services of the DHV if necessary. Please note the published data protection regulations necessary to that end.

Extent and purpose of data processing:

The computing proceeds through the DHV e.V. in fulfillment of its legitimate interests in terms of Art. 6 para. 1 sentence 1 lit. f) GDPR (DS-GVO) in accordance with its consent, particularly the following statutory aims of the association:

- collection of contributions in case of individual membership
- assignment of members to an association
- submission of the membership magazine and invitation to events (e.g. regional assemblies, JHV)
- issue of identity cards, technical passes and other IDs if applicable
- other services and activities additionally instructed by the user
- political representation towards government agencies and ministries

Legal basis for the processing of personal data, legitimate interest

Legal basis for the processing of data is Art. 6 para. 1 point 1 lit. b) GDPR (DS-GVO). The processing within the framework of a membership in an association or the initiation of such is equivalent to the processing to fulfill a contract.

Period of data storage

The data will be deleted, once it is no longer required for the attainment of its purpose of collection and unless barred by legal retention obligations.

Transfer to other authorities / offices and purpose of transfer

All data mentioned in cipher II. shall, in the scope of a job processing, be passed on to data processing companies for the purposes of accounting.

The data processing company processes data solely on behalf and with instructions from the responsible.

Use of personal data and appropriation

Our employees and the service providers appointed by us are obliged to secrecy and to compliance with the terms of the GDPR (DS-GVO) of the European Union as well as the Federal Data Protection Act. Contracted service providers have been carefully selected and commissioned, are bound to our instructions and are inspected on a regular basis.

Furthermore, all required technical and organizational measures will be taken to ensure data protection.

III. Rights of the data subject

Data processed on given consent

If you have provided consent on the processing of your data, you can revoke this at any time. Once you have expressed such a revocation towards us, it influences the admissibility of the processing of your personal data.

Please note that you cannot object to the data collection and processing if the data is collected from an association in the case of membership or applied admission and is only used to the grant of rights deriving from the membership. The duty of the association as responsible authority to comply with data protection and information obligations remains unaffected. Unless we do not process your personal data on the basis of your consent, in fulfillment of a common closed or outstanding contract (including membership in an association) or on other legal permissions, but furthermore on the weighing of interests according to art. 6 par. 1 sentence 1 lit. f) GDPR (DS-GVO), you can appeal against the processing. If you contradict the use in such a case, we kindly ask you to expose the reasons why your personal data shall not be processed according to our description. We will then examine the situation and either cease or adjust the processing of your data, or illustrate the compelling and legitimate grounds justifying the continuation of the processing.

Further rights

In addition, you have to following rights concerning your individual personal data

- Right of information (within a period of 4 weeks, once a year free of charge)
- Right to rectification and erasure, if no legal regulations or a membership related processing requires otherwise
- Right to restriction of processing
- Right to objection against processing
- Right to data portability
- Right to file a complaint concerning our processing of your personal data with a data protection supervisory authority

Automated decision making, profiling, data transfer to non EU states

The data shall not be used for automated decision making or a profiling. A data transfer to places outside the EU shall not take place.
